AGREEMENT

This Agreement is made and entered into as of the _____ day of _____, _____, between the Livermore Area Recreation and Park District, hereinafter referred to as LARPD and, _____
Whose address is _____ hereinafter referred to as "Contractor". Contents of this Contract Agreement are as follows:

1. Contractor certifies that he/she is a person trained and qualified to perform services for LARPD as **a soccer referee** and though these services are performed for hire, such services are not necessarily a contractors only occupation.
2. Contractor agrees to perform the following services **Officiate Adult Soccer Leagues for LARPD**. Such services to be performed at **site locations as scheduled and games times and dates as assigned.**
3. LARPD agrees to pay Contractor for the performance of such services, the sum of:

Single Referee _____ per game (\$ 35.00),	Center Referee (3ref syst) per game (\$30.00).
Two Referee system per game (\$ 25.00),	Linesman (3 ref syst) (\$ 10.00).
4. This Contract Agreement is deemed to be continuous. Contractor understands that LARPD may cancel this Agreement at any time should enrollment/participation be insufficient, or should funds or facilities become unavailable, or should the Contractor not perform the services herein to the satisfaction of LARPD, and that LARPD shall not be liable for compensation of the Contractor for the remainder of the Agreement should it be cancelled.
5. LARPD shall sponsor any Classes, Programs-Activities, Leagues-Tournaments, Races, and/or special events to be conducted by Contractor and shall at its expense make available to Contractor the times and on the dates set forth hereinafter above, the place at which said classes/activities-programs/events are to be held.
6. Contractor shall acquire, repair and maintain at his/her sole cost and expense such equipment as Contractor needs for his/her personal use of the conduct of the aforesaid services.
7. Contractor, in the conduct of the services contemplated hereunder shall abide by all laws, ordinances and by the rules and regulations adopted by LARPD relating thereto.
8. It is understood and agreed the Contractor in the performance of this contract, is an independent contractor and not an employee of LARPD or of any organization, group or individuals under Contractors supervision or leadership as a result of this contract, and is not subject to the control of LARPD except as herein above stated.
9. Contractor further agrees to accept all hazards and injuries which Contractor may receive in the course of performing this contract and agrees to hold harmless LARPD, the Board of Directors and each member thereof, all officers and employees of LARPD and any organization, group, or individual therein under the supervision of the Contractor which Contractor receives in the performance of his duties under the terms of this Contract or for any act of which Contractor may be adjudged liable. Contractor understands that LARPD has no accident or Workmen's Compensation insurance for persons performing services as an independent contractor.
